Conditions for participation:

- If the Property Owner or Occupier is not available to collect the treated baits –
- An **Authority for Agent to Sign Form must** be completed and faxed or e-mailed to Council or handed to baiting staff. Council will provide staff to apply a vertebrate pesticide to the prepared meat baits at the locations specified in the table.
- A plane will be available for the distribution of prepared baits if required.
- Landholders are required to have baits cut into 125-250gram sizes for dog baits.
- All landholders shall have their baits cut and ready for pesticide application by the start times indicated in table.
- **No rotten meat will be treated during the program.**
- Property owners or persons responsible **are required** to accompany the pilot to distribute baits ensuring effective distribution. A property map with GPS coordinates of desired bait areas is to be provided.

PLEASE REMEMBER TO TELL YOUR NEIGHBOURS OF YOUR INTENTION TO BAIT AT LEAST 72 HOURS PRIOR TO BAITING.

1. To lay poisoned baits at the risk of the Owner and in accordance with the Conditions. AND the Owner hereby acknowledges that he/she has received and read the Conditions (here over) including the 1080 Safety Sheet.
2. To indemnify and save harmless the Authority against all Claims and Losses which may be brought against or made upon the Authority or which the Authority may incur, sustain, expend or be put to by reason of the supply, impregnation or laying of poisoned baits and whether such Claims and Losses be occasioned by the act or default whether negligent or not on the part of the Owner or on the part of the Authority or otherwise AND the Owner **HEREBY RELEASES AND DISCHARGES** the Authority from any and all Claims and Losses which but for the provisions hereof might be brought against, or made upon the Authority by the Owner.
