Environmental Protection Act 1994 – Section 624

Registration certificate for existing operators of level 2 ERAs

Anyone conducting an environmentally relevant activity (ERA), other than a mining activity or a petroleum activity, is required to be a registered operator with the administering authority (AA). Section 624 of the Environmental Protection Act 1994 requires everyone operating a level 2 ERA under existing deemed approvals or development approvals to provide the AA with the information required by this form. No fee is required for obtaining a registration certificate for a level 2 ERA operated under an existing deemed approval or development approval if application is made by 4 October 2005. Otherwise an application must be made for a registration certificate and the appropriate fee is payable.
