Local Government Act 2009

McKinlay Shire Council (Making of Local Law) Website Notice (No. 1) 2019

Title

1. This notice may be cited as *McKinlay Shire Council (Making of Local Law) Website Notice (No. 1) 2019*.

Commencement

2. This notice commences on the date it is published on the website of McKinlay Shire Council.

Making of local laws

3. McKinlay Shire Council (the "Council") has, by resolution dated the **16th day of July 2019**, made local laws, which incorporate model local laws, as follows—
 - (a) Model Local Law No. 1 (Administration) 2010, to be known as Local Law No. 1 (Administration) 2019; and
 - (b) Model Local Law No. 2 (Animal Management) 2010, to be known as Local Law No. 2 (Animal Management) 2019; and
 - (c) Model Local Law No. 3 (Community and Environmental Management) 2010, to be known as Local Law No. 3 (Community and Environmental Management) 2019; and
 - (d) Model Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2010, to be known as Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2019.

Making of subordinate local laws

4. Council has, by resolution dated the **16th day of July 2019**, made subordinate local laws as follows—
 - (a) Subordinate Local Law No. 1 (Administration) 2019;
 - (b) Subordinate Local Law No. 2 (Animal Management) 2019;
 - (c) Subordinate Local Law No. 3 (Community and Environmental Management) 2019;
 - (d) Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2019.

Existing local laws repealed

5. The local laws referred to in paragraph 3 repeal existing local laws of Council as follows—
- (a) Local Law No. 1 (Administration) 2019 repeals—
 - (i) *Local Law No. 1 (Administration)*; and
 - (ii) *Local Law No. 2 (Cemeteries)*; and
 - (iii) *Local Law No. 3 (Meetings)*; and
 - (iv) *Local Law No. 6 (Control of Advertising)*; and
 - (v) *Local Law No. 13 (Caravan Parks and Camping) 2002*; and
 - (vi) *Local Law No. 14 (Temporary Entertainment Venues) 2004*.
 - (b) Local Law No. 2 (Animal Management) 2019 repeals—
 - (i) *Local Law No. 4 (Impounding of Animals)*; and
 - (ii) *Local Law No. 5 (Keeping and Control of Animals)*.
 - (c) Local Law No. 3 (Community and Environmental Management) 2019 repeals *Local Law No. 16 (Overgrown and Unsightly Allotments) 2005*.
 - (d) Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2019 repeals—
 - (i) *Local Law No. 7 (Parks and Reserves)*; and
 - (ii) *Local Law No. 8 (Public Aerodromes)*; and
 - (iii) *Local Law No. 9 (Swimming Pools)*; and
 - (iv) *Local Law No. 10 (Water)*; and
 - (v) *Local Law No. 11 (Roads)*; and
 - (vi) *Local Law No. 12 (Commercial Use of Roads) 2002*; and
 - (vii) *Local Law No. 15 (Gates and Grids)*; and
 - (viii) *Local Law No. 23 (Libraries)*.

Model local laws incorporated

6. Each of the local laws referred to in paragraph 3 incorporates a model local law as detailed in paragraph 3.

Local law that authorises a subordinate law to be made

7. The local laws referred to in paragraph 3 authorise the making of the subordinate local laws referred to in paragraph 4 as follows—
- (a) Local Law No. 1 (Administration) 2019 authorises the making of Subordinate Local Law No. 1 (Administration) 2019;
 - (b) Local Law No. 2 (Animal Management) 2019 authorises the making of Subordinate Local Law No. 2 (Animal Management) 2019;

- (c) Local Law No. 3 (Community and Environmental Management) 2019 authorises the making of Subordinate Local Law No. 3 (Community and Environmental Management) 2019;
- (d) Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2019 authorises the making of Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2019.

Purpose and general effect

- 8. The purpose and general effect of each local law identified in schedule 1, column 1, and each subordinate local law identified in schedule 1, column 2, is identified in the corresponding part of schedule 1, column 3.

Local laws that contain an anti-competitive provision

- 9. If a local law identified in schedule 1, column 1, or a subordinate local law identified in schedule 1, column 2, contains an anti-competitive provision, that fact is identified in the corresponding part of schedule 1, column 4.

Inspection

- 10. A copy of each local law identified in schedule 1, column 1, and each subordinate local law identified in schedule 1, column 2, may be—
 - (a) inspected and purchased at Council's office at 29 Burke Street, JULIA CREEK QLD 4823; and
 - (b) viewed by the public on the website of the Department of Local Government.
